E - BANKING TERMS AND CONDITIONS FOR PRUDENTIAL BANK LIMITED

1. This E - Banking Service provided by Prudential Bank is exclusively for personal use and therefore not transferable.
2. The use of Electronic Banking Facilities shall be subject to Prudential Bank's prevailing rules and regulations. It should not be used for any purpose other than the transactions designated by the Bank.
3. I will keep my Personal Identification Number (PIN) strictly confidential and undertake not to reveal such number to any person at any time under any circumstances.
4. I undertake to keep Prudential Bank informed immediately in the event of a loss, misplacement or theft of my Personal Identification Number (PIN). Failure to do so makes my account liable to fraudulent activities. Prudential Bank would not be responsible in anyway whatsoever for any unauthorized transaction(s) on my account during this period.
5. I accept full responsibility for all transactions processed from the use of Electronic Banking Facilities offered by the Bank.
6. Prudential Bank has the authority to debit my account(s) with all charges that Prudential Bank may charge for my use of Electronic Banking Facilities, and also with any other liabilities inclusive of legal fees or other statutory charges, if any, relating to the use of Electronic Banking Facilities.
7. Prudential Bank is not bound to carry out the instructions given through Electronic Banking Facilities, if the Bank at its sole discretion believes that such instructions do not emanate from the customer.
8. Prudential Bank will not be liable, responsible or accountable in anyway whatsoever arising for any malfunction or failure of the Electronic Banking Facilities or for the failure or delay of Prudential Bank to act on instructions given via this medium.
9. At no time would I use or attempt to use the Electronic Banking Facilities to execute transfer of funds, unless sufficient funds are available in my account. Prudential Bank is under no obligation to honor any payment instructions unless there are sufficient funds in designated account/s at the time of receiving such payment instructions.
10. In the event of a Joint Account, We will be jointly liable for all transactions arising from the use of the Electronic Banking Facility.
11. I accept(s) now and would accept hereafter Prudential Bank's record of transactions as conclusive and binding for all purposes.
12. Prudential Bank shall not be responsible for any loss or damage incurred or suffered by the customer as a result of non-acceptance of instructions given on Electronic Banking Facility.
13. Prudential Bank shall at any time be entitled to amend, supplement or vary any of these terms and conditions as well as the fees applicable at its absolute discretion with or without notice to me/us and such amendment, supplement or variation shall be binding on me/us.
